Policy It is the policy of Communities Connected for Kids (CCKids) to follow through with requirements of the court, support all efforts to implement the requirements of the case plan, and to facilitate the completion of tasks, especially as they relate to the high risk factor of parental substance abuse.

Procedure

1. Parents and/or family members referred to CCKids may be required to participate in random substance abuse screening as part of the child's case plan and/or court orders. The Dependency Case Manager (DCM) may be responsible for coordinating those services (This will be specified in court orders and in the judicial case plan).
2. The DCM will discuss the terms of the screening and payment schedule with the family member in response to the requirements of the case plan or court orders.
 - a. DCM can refer caregiver to the Substance Abuse Call Center (SACC) for a brief risk inventory and schedule assessment via 211 (brochure attached).
3. Results of the screening will be delivered back to the DCM by the screening site; screenings/assessments completed via SACC will be uploaded in to FSFN.
4. The documented results will be filed in the child's case file and made available to Children's Legal Services (CLS) and the court as required by the case plan/court orders.
5. If substance abuse treatment is required, the DCM will coordinate with the service provider to ensure that treatment plans and services are coordinated with the child's case plan and services.
6. At each meeting with the family, the DCM will review treatment and testing progress and results with the family members.
7. All interventions related to substance abuse services will respect the rights of clients as defined in Chapter 397.501.

Call Center Process

Utilizing the Screening and Assessment Call Center

Call SACC at 211 – once the automation begins, hit #. Identify yourself, the case ID number, the clients name and describe the situation.

Place the client on the phone with SACC for a brief risk inventory and to schedule an appointment for assessment.

Speak to SACC after the risk inventory to confirm appointment time and location. Confirm your contact information for future communication.

After the Initial Risk Inventory Call

SACC will notify the CPI/DCM, their Supervisor and the provider of the clients scheduled appointment via email and FSFN Entry.

SACC will call the client to remind them of their appointment 24 hours in advance and confirm they have reliable transportation. If not, SACC will assist with transportation planning.

SACC will confirm with the provider via FSFN that the client attended their appointment.

What SACC can do for you

- Conduct a brief risk inventory and schedule client assessments
- Communicate scheduled appointments to the provider
- Follow-up with the client to remind them of their appointment and assist them with directions or transportation planning
- Confirm with the provider via FSFN the client has attended their appointment
- Confirm appointment times and locations for CPI/DCM staff or provider anytime, 24 hours a day, 7 days per week

If you have a history of drug or alcohol abuse, a judge may question your ability to be a good parent and provide your children with a safe and caring environment. By admitting you have a problem with alcohol or drugs, you and your children can begin the rewarding journey to a better life.
