We want you to stuff it - with school supplies

PORT ST. LUCIE, June 26, 2019 — CCKids is looking for volunteers to help Stuff the Bus from 9 a.m. to 3 p.m., Saturday, July 20, at the Port St. Lucie Wal-Mart on U.S.1.

The event, now in its 15th year, is part of the United Way of St. Lucie County's Tools for Schools drive, which collects school supplies for needy children from the entrances of St. Lucie County Wal-Mart stores.

The project is expected to serve more than 10,000 children this year, with much of the donations coming from the four Stuff the

Bus sites and from corporate contributors like Publix.



CCKids, which will host the U.S.1 site, will receive enough supply-stuffed backpacks for 300 children in the child-welfare system.

"We need volunteers to greet shoppers, hand out flyers and collect supplies from donors," said Christina Kaiser, CCKids Community Relations Director and site coordinator.

"It's an especially easy and fast way for high-school students to get the community service hours they need for graduation and college scholarships," she said.

What is the Quality Parenting Initiative?

The Quality Parenting Initiative - or QPI - is an approach to strengthening foster care by refocusing on excellent parenting for all children in the child welfare system.

It was launched by the Youth Law Center in 2008 in Florida, and is now in

more than 10 states and 75 jurisdictions. The initiative is an approach and a philosophy, but it is also a network of sites that share information and ideas about how to improve parenting as well as recruit and retain excellent families.

Communities Connected for Kids is one of those sites, and we are committed to fully supporting excellent parenting by prioritizing the needs of the child - first by defining and communicating the expectations of caregivers and then by aligning system policy and practice to those expectations

When QPI is successful, caregivers receive the support and training they need to work with children and families, understand what is expected of them, and know what to expect from the system.

In return, our system is able to select and retain enough excellent caregivers to meet the needs of each child for a home and family. When these changes are accomplished, outcomes for children, youth and families improve.

Although LGBTQ youth enter the foster-care system for the same reasons as other children in care, many have the added trauma that comes with being rejected or mistreated because of their sexual orientation, gender identity or gender expression.

FL: Homes to Heal Trafficked Children New York Times - June 19, 2019

Miami is one of 13 cities considered by the FBI to be a hub for child sex trafficking. While there are no reliable estimates of how many children have been trafficked in the United States - the most conservative estimates hover around 3,000 - it's the most vulnerable children who are most often targeted.
