About This Enhancement
AFCARS collects case-level information on all children in foster care and those who have been adopted with title IV-E agency involvement. The data includes information about children who enter foster care, their entries and exits, placement details, and foster/adoptive parent information. AFCARS data impacts how federal title IV-E foster care and adoption assistance programs are funded. Timely and accurate data collection is essential.

Flag all pregnancy fields, on the Medical/Mental Health page, as 'Old' within the Medical/Mental Health Universe.
