# AFCARS-45: EDUCATION HISTORY - CURRENT GRADE LEVEL

- The Current Grade Level drop-down, on the Maintain Education History pop-up page, inactivates the following values: College Degree; Post-Graduate Degree; Associate Degree.
  - Please Note: You will no longer be able to select values from the Current Grade Level drop-down that indicate a "degree."
- Upon accessing a pre-existing page where these values were selected, the value will display as "Inactive Value: <value>."

**NOTE:** The Education History tab should also reflect the "Grade" as "Inactive Value."

# AFCARS-48: EDUCATION RECORD - VALIDATION TO SAVE

A validation is added to the Education record such that upon saving the Education record, whether upon initial save or any subsequent save, at least one Education record must be documented.



# AFCARS-49: EDUCATION RECORD – EXCEPTIONAL STUDENT EDUCATION (ESE)

- It is no longer a requirement to indicate if the child is an ESE student to document if the child has an Individualized Education Plan (IEP).
- Upon creating or accessing a pre-existing Education record, the question "Does the child have an Individualized Education Plan?" will be enabled irrespective of whether the question "Is the child an Exceptional Student Education (ESE) student?" is answered or not.
- The question should be enabled but not required when ESE question is not answered. Continue existing logic that if ESE is Yes, then a response is required for IEP.
- The remaining questions should remain as they are, which is driven based on Yes being selected to IEP.



# AFCARS-50: EDUCATION RECORD – INDIVIDUALIZED FAMILY SERVICE PROGRAM (IFSP)

- The ability to indicate if the child has an Individualized Family Service Program for children between the ages of 0-3.
- A new question has been added, "Does the child have an Individualized Family Service Program (IFSP)?" with a Yes/No selection.
- This question will be displayed directly below the question "Date Current Individualized Education Plan Expires:" and will be conditionally enabled but not required if the person is 0-3 based on DOB; and if no DOB, based on Est. Age; if there is no DOB or Est. Age, then we conditionally enable the field,
- Upon selecting Yes or No, a validation message will pop up asking DOB or Est. Age.
- If a child is >3, it will be disabled and grayed out.

  - The new date field is conditionally enabled and required upon selecting Yes to the existing question "Child Was Previously Adopted"; the date can be current or past, but not future.

# AFCARS-52: PERSON MANAGEMENT - PRIOR ADOPTION

- If the date of the most recent adoption is unknown, the Child Welfare Professional would select the “Unknown” checkbox.
  - Upon selecting the Unknown checkbox, the Most Recent Adoption Finalization Date field will be disabled, grayed out and not required
- Child Welfare Professionals must document "Was the most recent, prior adoption, an intercountry adoption?"
  - The selection of Yes, No or Unknown is conditionally enabled and required upon selecting Yes to the existing question "Child Was Previously Adopted."
- All pre-existing records with Unable to Determine will reflect Abandoned.

- Prior Legal Guardianship question has a drop-down containing the options 'Yes', 'No' and 'Abandoned'.
  - When the 'No' or 'Abandoned' option is selected a date is not required;
  - When the 'Yes' option is selected a date is required;
  - The "Most Recent Legal Guardianship Date" field can be current or past, but not a future date\*.

# AFCARS-72 MEDICAL/MENTAL HEALTH PAGE-PREGNANCY INFORMATION

- Child welfare professionals CANNOT document pregnancy details on the Medical/Mental Health page. The Medical/Mental Health page Disability and Pregnancy tab has been changed to Disability Information.
- Any pre-existing records where there is at least one record inserted within the Pregnancy and Parenting Information group box will remain, but the Insert button will always be disabled and grayed out. Any pre-existing records will continue to be modifiable, but no new records will be able to be inserted.
- For any pre-existing records where there are No records inserted within the Pregnancy and Parenting Information group box, and for all newly created Medical/Mental Health pages, the group box will no longer display.

- The Insert button is disabled if the Gender is not documented or if the Gender is Male or Unknown. The Insert button is conditionally enabled only if the Gender is Female.
- Upon clicking the Insert button, a new row populates the table, and the Date Notified of Pregnancy and Projected Due Date are enabled and required.
- The Date Notified of Pregnancy will allow a current or past date, but not a future date. Upon entering a future date and clicking save, the following validation message displays, "Date Notified of Pregnancy cannot be a future date." The Projected Due Date can be prior to, equal to or greater than the Date Notified of Pregnancy, and can be past, current or future dated.

- The Date of Child's Birth can be prior to, equal to, or greater than the Projected Due Date; it can be a current or past date but cannot be a future date. Upon entering a future date and clicking save, the following validation message displays, "Date of Child's Birth cannot be a future date." Any record inserted will have a Delete hyperlink displayed, allowing the user to delete an inserted record, in the event it was inserted in error
- If there is at least one record in the Pregnancy Details group box and the user changes the Gender from Female to Male or Unknown, upon attempting to save a validation message is received that states that: You are attempting to change the gender of this participant, while there is at least 1 Pregnancy Details record documented on the AFCARS/Other Participant Information tab. # AFCARS-75: BIRTH AND PLACEMENT DETAILS - PARTICIPANT SELECTION POP-UP PAGE

- The new Participant Selection pop-up page will display when needing to add participants, the pop-up page will capture a group box labeled Case Participants. A repeating table will be displayed, and will pre-fill with all FSFN Case Participants who are under the age of 18, based on their DOB; if no DOB, it will look at Est Age; if no DOB or Est Age, it will treat them as if they are 18 or over
- A Continue and Close button will be displayed in the bottom right corner. Upon selecting at least 1 checkbox, the Continue button will be conditionally enabled; otherwise, disabled. Close button is always enabled. Upon selecting at least 1 checkbox, clicking Continue, and returning to the Person Management page, a new record will be captured in the table, and the user must click Save to commit the selection to the database. Upon selecting Close, if at least one checkbox was selected, the user will receive a prompt asking if they are sure they wish to Close without saving their selection, with a Yes and No button. Upon selecting Yes, the user will be returned to the Person Management page without having a selection made. Upon selecting No, the user will remain on the Participant Selection pop-up page.
- Once a child is included in this table, if the user attempts to remove the Date of Birth or Estimated Age or modify the age of that child which results in the child not having a DOB or Estimated Age, or being 18 or older, respectively, a validation message will be displayed that states the following: “You are attempting to either remove or modify the DOB or Estimated Age, which will result in this child not having a DOB or Estimated Age, or being 18 or older, while this child is currently identified as a child to a young adult parent”. - **Commercial Sexual Exploitation of Child (CSEC):** The child is a victim of sex trafficking at the time of removal.



# AFCARS ELEMENTS 75-105: CHILD AND FAMILY CIRCUMSTANCES AT REMOVAL – EXISTING REASONS

- **Physical Abuse:** Alleged or substantiated physical abuse, injury, or maltreatment of the child by a person responsible for the child's welfare.
- **Sexual Abuse:** Alleged or substantiated sexual abuse or exploitation of the child by a person responsible for the child's welfare.
- **Emotional Abuse/Neglect:** Alleged or substantiated psychological or emotional abuse, including verbal abuse, of the child by a person who is responsible for the child's welfare.
- **Physical Neglect:** Alleged or substantiated negligent treatment or maltreatment of the child, including failure to provide adequate food, clothing, shelter, supervision, or care by a person responsible for the child's welfare.
- **Medical Neglect:** Alleged or substantiated medical neglect caused by a failure to provide for the child's appropriate health care by a person responsible for the child's welfare, although the person was financially able to do so or was offered financial or other means to do so.



# AFCARS ELEMENTS 75-105: CHILD AND FAMILY CIRCUMSTANCES AT REMOVAL – EXISTING REASONS

- **Domestic Violence:** Alleged or substantiated violent act(s), including any forceful detention of an individual that results in, threatens or attempts to cause physical injury or mental harm. A person commits this act against another individual residing in the child's home and with whom such person is in an intimate relationship, dating relationship, is or was related by marriage, or has a child in common. This circumstance includes domestic violence between the child and their partner and applies to a child or youth of any age, including those younger and older than the majority. This situation does not include alleged or substantiated maltreatment of the child by a person responsible for the child's welfare.
- **Diagnosed Condition** (changed from 'Child's Disability'): The child has a clinical diagnosis by a qualified professional of health, behavioral or mental health condition, such as one or more of the following: Intellectual disability, emotional disturbance, specific learning disability, hearing, speech or sight impairment, physical disability or other clinically diagnosed condition.



# AFCARS ELEMENTS 75-105: CHILD AND FAMILY CIRCUMSTANCES AT REMOVAL – EXISTING REASONS

- **Child Behavior Problem:** The child's behavior in school and/or community adversely affects their socialization, learning, growth, and/or moral development. This situation includes all child behavior problems, adjudicated and non-adjudicated status or delinquency offenses and convictions.
- **Alcohol Abuse (Parent):** A parent, legal guardian, or other caretaker responsible for the child uses alcohol compulsively that is not of a temporary nature.
- **Drug Abuse (Parent):** A parent, legal guardian or another caretaker responsible for the child uses drugs compulsively that are not of a temporary nature.
- **Alcohol Abuse (Child):** The child uses alcohol.
- **Drug Abuse (Child):** The child uses drugs.



# AFCARS ELEMENTS 75-105: CHILD AND FAMILY CIRCUMSTANCES AT REMOVAL: EXISTING REASONS

- **Death of Parent(s)/Caretaker(s)** (changed from 'Death of "Parent(s)'): Existing family stress in caring for the child or an inability to care for the child due to the death of a parent, legal guardian or another caretaker.
- **Incarceration of Parent(s)/Caretaker(s)**: (changed from 'Incarceration of Parent(s)') Existing family stress in caring for the child or an inability to care for the child due to the death of a parent, legal guardian, or another caretaker.
- **Inadequate Housing**: The child's or his or her family's housing is substandard, overcrowded, unsafe, or otherwise inadequate, resulting in it being inappropriate for the child to reside.
- **Extended Foster Care 18+**: The child - age 18 or older - has requested placement into foster care.





# AFCARS ELEMENTS 75-105: CHILD AND FAMILY CIRCUMSTANCES AT REMOVAL: NEW REASONS

- **Runaway:** The child has left, without authorization, the home or facility where the child was residing.
- **Whereabouts Unknown:** The child's whereabouts are unknown but not considered to have run away.  
*Note: 'Runaway' and 'Whereabouts Unknown' should not be selected together. These two values will be added to FSFN on 11/04/2022.*
- **Failure to Return:** The parent, legal guardian, or caretaker did not or has not returned for the child or made his or her whereabouts known. This category does not apply when the identity of the parent, legal guardian or caretaker is unknown.
- **Prenatal Alcohol Exposure:** The child has been identified as prenatally exposed to alcohol, resulting in fetal alcohol spectrum disorders such as fetal alcohol exposure, fetal alcohol effect, or fetal alcohol syndrome.
- **Prenatal Drug Exposure:** The child has been identified as prenatally exposed to drugs.



# AFCARS ELEMENTS 75-105: CHILD AND FAMILY CIRCUMSTANCES AT REMOVAL – NEW REASONS

- **Caretaker’s Significant Impairment-Physical/Emotional:** A physical or emotional illness or disabling condition of the child's parent, legal guardian or caretaker that adversely limits his or her ability to care for the child.
- **Caretaker’s Significant Impairment-Cognitive:** The child's parent, legal guardian or caretaker has cognitive limitations that impact his or her ability to function in areas of daily life, which adversely affect his or her ability to care for the child. It also may be characterized by a significantly below-average score on a test of mental ability or intelligence.
- **Inadequate Access to Mental Health Services:** The child and/or child's family has inadequate resources to access the necessary mental health services outside of the child's out-of-home care placement.
- **Inadequate Access to Medical Services:** The child and/or child's family has inadequate resources to access the necessary medical services outside of the child's out-of-home care placement.



# AFCARS ELEMENTS 75-105: CHILD AND FAMILY CIRCUMSTANCES AT REMOVAL – NEW REASONS

- **Educational Neglect:** Alleged or substantiated failure of a parent or caregiver to enroll a child of mandatory school age in school or provide appropriate home schooling or needed special educational training, thus allowing the child or youth to engage in chronic truancy.
- **Family Conflict Related to Child’s Sexual Orientation, Gender Identity, or Gender Expression:** There is family conflict related to the child’s expressed or perceived sexual orientation, gender identity, or gender expression. This includes any conflict related to the ways in which a child manifests masculinity or femininity.
- **Homelessness:** The child or their family has no regular or adequate place to live. This includes living in a car, or on the street, or staying in a homeless or other temporary shelter.
- **Parental Immigration, Detainment, or Deportation:** The parent is or was detained or deported by immigration officials.



# AFCARS ELEMENTS 75-105: CHILD AND FAMILY CIRCUMSTANCES AT REMOVAL – NEW REASONS

- **Public Agency Title IV-E Agency Agreement:** The child is in the placement and care responsibility of another public agency that has an agreement with the title IV-E agency pursuant to section 472(a)(2)(B) of the Act and on whose behalf title IV-E foster care maintenance payments are made.
- **Tribal Title IV-E Agreement:** The child is in the placement and care responsibility of an Indian tribe, tribal organization or consortium with which the title IV-E agency has an agreement and on whose behalf title IV-E foster care maintenance payments are made.

**NOTE:** These are only used to identify children in the reporting population who are under a title IV-E agreement with a public or tribal agency and are receiving a title IV-E foster care maintenance payment. These elements would not be reported for a child under the placement and care responsibility of the reporting title IV-E agency.
